## Annual income qualifications:



Individuals = \$40,000 or less



## Families = \$60.000 or less

\*We are not able to do your taxes if you have income from driving a cab, rental income, filed bankruptcy or had any transaction involving crypto currency in the tax year you wish to file. There are other, less common situations that are out of scope.

## **1. Personal Information**

- □ Picture ID for taxpayer and spouse. If filing jointly, both must be present
- □ **Birthdate** for all persons listed on the tax return
- Social Security card or Individual Tax Identification Number (ITIN) letter for all persons listed on the tax return
- □ Routing and account numbers for your savings account, checking account, and/or prepaid card

### 2. Year-End Income Statements

□ W-2s for each job

- □ **1099** forms for retirement, Social Security, unemployment, interest, dividends, stock sales, selfemployment, and miscellaneous income
- □ Year-end amounts for MFIP, SSI, MSA, GA, veterans' benefits, and workers' compensation

## 3. Education and Child Care Credits

- □ Record of **educational expenses** you paid for your children in grades K-12
- □ **Tuition expenses** paid for you or your child to attend a college or university (Form 1098-T)
- □ Student loan **interest statement** (Form 1098-E)
- □ Child care expenses: Provider name, address, and tax ID or Social Security number

## 4. Property Tax Refunds

- □ Homeowners: 2024 Property Tax statement mailed by the county in March
- □ **Renters:** Certificate of Rent Paid (CRP)
- □ Mobile home owners: All of the homeowner and renter documents listed above

### **5. Additional Documents**

#### $\square$ Previous year's **tax return**

- □ Verification of **health insurance** if purchased through MNsure (Form 1095-A)
- □ Record of charitable **donations**

## SELF-EMPLOYMENT TAX PREP

Tax assistance is available by appointment for independent contractors and sole proprietors at P+P's main office. Go to **prepareandprosper.org**, or call **651-262-2169** to schedule a self-employment tax appointment instead of a regular appointment if one of the following applies:

- Your annual self-employment income is over \$10,000\*
- You operate a daycare, or
- You use your home for your business.

\*Total income, including self-employment income, must meet P+P income qualifications.

## **NEW + EXPANDED** TAX CREDITS IN MN

Along with federal tax credits like the Earned Income Tax Credit (EITC), Minnesota has new and expanded tax credits you may be eligible for this year. You may still qualify even if you don't usually file a tax return.

NEW Minnesota Child Tax Credit: You can claim up to \$1,750 per child under age 18.

**EXPANDED Working Family Credit:** You can claim up to \$350 for individuals and up to \$2,850 for families.

EXPANDED K-12 Education Credit: You can claim this credit for school expenses with income up to \$76,000. Save your receipts!

Newborn Credit: You can claim a Child and Dependent Care credit if you had a baby in 2023.

Minnesota also has credits for renters, homeowners, and people paying back student loans.

Attention ITIN Filers! All Minnesota tax credits are now available to people filing taxes with an Individual Taxpaver Identification Number (ITIN)! Homeowners with an ITIN now qualify for homestead status and the property tax refund for homeowners.
